

Terms and Conditions

Please read these terms and conditions carefully before using Our Service.

Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of these Terms and Conditions:

Affiliate means an entity that controls, is controlled by or is under common control with a party, where "control" means ownership of 50% or more of the shares, equity interest or other securities entitled to vote for election of directors or other managing authority.

Account means a unique account created for You to access our Service or parts of our Service.

Country refers to: Queensland, Australia

Company (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to IPCIUM Pty Ltd, 213 Brisbane St, Ipswich QLD 4305.

Content refers to content such as text, images, or other information that can be posted, uploaded, linked to or otherwise made available by You, regardless of the form of that content.

Device means any device that can access the Service such as a computer, a cellphone or a digital tablet.

Feedback means feedback, innovations or suggestions sent by You regarding the attributes, performance or features of our Service.

Free Trial refers to a limited period of time that may be free when purchasing a Subscription.

Service refers to the Website.

Subscriptions refer to the services or access to the Service offered on a subscription basis by the Company to You.

Subscriptions

Subscription period

The Service or some parts of the Service are available for the duration of the Pilot Trial for a fixed term period, to support the Beta Testing of the Service. During this Pilot Trial you will not be billed for your subscription to use the Service.

Upon conclusion of the Pilot Trial and upon completion of the Pilot Trial period, you may be provided with a free 12x month subscription. Should you accept the offer for a free 12x month subscription, we would seek and expect your continued feedback over the period.

At the end of the initial 12x month free trial period, Your Subscription would automatically renew under the Subscription agreement arrangements selected in advance on a recurring and periodic basis (such as daily, weekly, monthly or annually), depending on the type of Subscription plan you select when purchasing the subsequent Subscription.

Subscription cancellations

Billing

During either the Pilot Trial Period or the free 12x Month Subscription period, You may be asked to provide the Company with accurate and complete billing information including full name, address, state, zip code, telephone number, and a valid payment method information, for the purposes of testing the Service. We will not test any billing functionality without providing you with 10 days notice.

Fee Changes

With the exclusion of the Pilot Trial period and initial 12x month free offer period, the Company, in its sole discretion and at any time, may modify the Subscription fees. Any Subscription fee change will become effective at the end of the then-current Subscription period.

The Company will provide You with reasonable prior notice of any change in Subscription fees to give You an opportunity to terminate Your Subscription before such change becomes effective.

Refunds
